

he United Nations Organisation (UNO) was created for the maintenance of international peace and security, development of friendly relations among the nations, achievement of international cooperation in solving international problems and promotion and encouragement of respect for human rights and fundamental freedom for all without distinction "of race,' sex,' language' or 'religion. Inspite of the various programmes to promote the percentage of the literacy rate, atleast half of the world's population at present can not read and write. Therefore. UNESCO attaches great importance to the imparting of education to children as well as adults. Our country operating within the frame work of the UN charter, implements various programmes to promote the basic and higher education.

In each and every country, the national and regional, and sub regional level educational institutions function to promote education as a basic human right. For this purpose, the Central and State governments have sanctioned financial assistance and help to the every individual for the award of scholarship, fellowship, organised workshop and training programmes for the strengthening of respect for human rights.
